

HORSE SHOW PARKING 2010
MARIAN COLLEGE & BECTIVE RUGBY GROUNDS
- TERMS & CONDITIONS -

1. Limited parking is available in the Marian College (Trucks) and the Bective Rugby Grounds (Trailer). It is therefore advisable to book as soon as possible.
2. All booking forms, accurately filled in and signed by the vehicle owner, must be lodged with, or sent by post to the "Equestrian Department, Royal Dublin Society, Ballsbridge, Dublin 4", together with the total fee. **Cheques, postal or money orders must be made payable to the "Royal Dublin Society" or RDS.**
3. No booking will be accepted unless it is made on the booking form overleaf and accompanied by the full amount of fees.
4. **All booking fees must be paid in EURO** and if paid by cheque, must be drawn on a R.O.I. denominated account. **Sterling cheques will not be accepted. All cheques, postal or money orders must be made payable to the "Royal Dublin Society" or RDS.**
5. Bookings will be accepted until **Friday 23 July 2010, at 5pm**. A refund of 60% of the booking fee will be made to any vehicle owner who cancels his / her booking in writing on or before the 23 July 2010.
6. A ticket will be issued on the condition that the owner complies with the regulations and orders of the stewards and attendants in charge of the premises. In the event of the holder's non-compliance, the ticket may be cancelled and the holder asked to remove his vehicle from the premises.
7. The ticket issued must be displayed on the vehicle at all times and is non-transferable.
8. The premises will be open from 12 noon on Sunday 1 August until 12 noon Monday 9 August. Vehicles remaining on the premises following this time will be subject to a fine of €50 a day.
9. No dogs, horses or any other animal is allowed on the premises.
10. Occupiers of vehicles are requested to assist in keeping the premises tidy and clean and to place all litter in the bins provided.
11. Under no circumstances can any vehicle be 'mucked out' anywhere within the confines of the premises.
12. Gas barbeques only, no open fire.
13. No vehicle will be permitted to move freely within the grounds. Vehicles must be parked in the allocated space until final departure.
14. Occupants of vehicles are asked to cooperate with security staff at all times.
15. If there are insufficient bookings the RDS reserves the right to cancel the parking arrangements. Should such circumstances arise a full refund will be made.
16. Neither the Society nor any of its officers, officials or servants shall be in any way responsible or accountable for anything that may happen (from any cause or circumstance whatsoever) to a vehicle owner or their servants, or agents, or to any vehicle or property brought onto the premises. The Society shall not, in any way be responsible for, or accept any liability for vehicles left on the Premises after 12 noon on Monday 9 August. Each vehicle owner shall be solely responsible for any consequential or other loss, injury or damage done to or occasioned by, or arising from any vehicle, and shall indemnify the Society against all legal or other proceedings in regard thereto and take out appropriate insurance cover for this purpose.
